Membership Definitions

The Northern Illinois Jeep Alliance (N.I.J.A.) offers three types of memberships to our organization. These are broken down into two categories: **Voting Members** (General & Secondary) and **Non Voting Members** (Associate).

➤ **VOTING MEMBERS** are described by our bylaws as follows:

“Persons seeking membership in the N.I.J.A. as regular voting members must meet the following requirements:

- a. Own a Jeep CJ, YJ, TJ, Cherokee, Pickup or other “Jeep” brand vehicle with four wheel drive.
- b. Be a legally licensed driver, at least 18 years of age.
- c. Must show proof of adequate liability insurance.
- d. Must agree to join the United Four Wheel Drive Association.

The prospective regular voting member will become eligible for membership upon completion of the above requirements.”

The two types of Voting Memberships are:

General Membership

Entitles your immediate family to participate in all N.I.J.A. functions, (1) voting privilege for the primary voting member, (1) membership packet, (1) newsletter, and membership in the Illinois Four Wheel Drive Association for the primary voting member. This also entitles the primary voting member to hold any office of the N.I.J.A.

Secondary Voting Membership

Entitles a second person, of the primary voting members immediate family living in the same household, to (1) voting privilege, (1) membership packet, and membership in the Illinois Four Wheel Drive Association. This also entitles the secondary voting member to hold any office of the N.I.J.A.

➤ **NON VOTING MEMBERS** are described by our bylaws as follows:

“By nomination of the board of Directors and/or by majority vote of the membership present at any general membership meeting, any person or business may be elected to Associate Membership in the N.I.J.A., shall pay dues, shall not be entitled to vote, and shall not be entitled to hold any office of the N.I.J.A.”

The type of Non Voting Membership is:

Associate Membership

This type of membership is used for those persons who meet the requirements listed above for a voting member but are under the age of 18. This type of membership is also used for those persons or businesses who wish to support the N.I.J.A.

DUES

Dues are \$39 per year.
